Dear Member:

The Owner Operator Independent Drivers Association Foundation has been awarded a grant from the Environmental Protection Agency (EPA) to administer an Innovative Finance Program to help small business truckers obtain Auxiliary Power Units (APUs). The grant will pay 40 percent of the cost to purchase and install the units. To be eligible applicants must meet all EPA requirements and program guidelines:

- Must be an OOIDA member
- Only new installations approved under the Innovative Finance Program
- Truck must be titled in the applicant's name
- Applicants must apply for a 3 year loan through the OOIDA Equipment Finance Department
- Only Auxiliary Power Units and only those certified by the EPA. A list of certified APUs is included (discounts currently offered to members on 3 of the certified APUs)
- Complete and return the accompanying questionnaire to help the EPA and the Foundation determine the best possible emissions reduction benefit
- Complete and return the credit application and supporting documents.
- An Electronic Control Module download of the idling time for 1 year prior to installation must be obtained to establish an emissions reduction baseline. The ECM printout must be sent to the Foundation on or about the installation date. Additional ECM readings or readings from the hour meter on the APU will be required twice each year for 3 years to evaluate the reduction in idling time. All ECM downloads will be at your expense

If you are selected and the loan is funded, the first rebate check will come to you after you make your first loan payment. Each subsequent rebate check will be mailed to you on the 6-month anniversary of the loan origination date, but only after you have provided a current ECM or APU hour meter reading. There will be 7 rebates in all covering 40% of the cost. Example: \$10,000 for APU and installation x 40% / 7 = \$571.43 per rebate check.


Funding for 2008 is now available. There will be additional funds in 2009 and 2010. Funds will be awarded through a selection process that includes checking member status, scoring the questionnaire and running a credit check. Eligible applicants will be electronically selected at random for the grant award. There will be three selections for funding as follows:

- 2008 - applications must be received by December 5, 2008 (approximately 50 awards)
- 2009 – applications will be review to the time that we reach our 2009 spending limit.
- 2010 - application deadline to be announced in late 2009

Eligible applicants that are not randomly selected in one or both of the first two years will have another chance to be selected the next year until all funds are expended in 2010.
